O R D E R

Whereas, it has been requested by the Executive Engineer, Shimla Division No.III, HPPWD, Shimla-3 to close the traffic on the road from Talland to Khalini Junction (during night hours) for execution of Metalling/ Tarring work of road from Talland to Khalini Junction.


And whereas, keeping in view the urgency of the work and the recommendation of the Superintendent of Police, Shimla, it is necessary to issue the order to restrict the traffic on the above road for the execution of Metalling/ Tarring work. The Superintendent of Police, Shimla has further requested to divert the vehicular traffic during night hours 10.00PM to 05.30AM as under:

- I. Traffic moving from Talland towards Khalini Junction may be diverted via Talland- Chhota Shimla- Brockhurst- Kasumti and vice versa.
- II. All buses coming from Upper Shimla to ISBT may commute via: Chhota Shimla-Old Bus Stand- ISBT.
- III. All buses coming from BCS to Old Bus Stand may commute via: Khalini- ISBT- Tutikandi Crossing- Old Bus Stand.
- IV. All Buses departing from Old Shimla towards BCS, New Shimla or Vikasnagar may follow the route: Old Bus Stand –Tutikandi Crossing- ISBT- Lower Khalini- BCS.

Now therefore, I, Anupam Kashyap, IAS, District Magistrate, Shimla in exercise the powers vested in me under section 115 & 117 of Motor vehicles Act, 1988 and all other powers enabling me in this behalf hereby order to restrict all type vehicles (except emergency vehicles) on the Talland to Khalini Junction w.e.f. 28-05-2025 to 29-05-2025 at night hours i.e. 10.00 PM to 05.30 AM for execution of Metalling/ Tarring work. Further, it is ordered that the vehicular traffic will be diverted as under:

- I. Traffic moving from Talland towards Khalini Junction will be diverted via Talland- Chhota Shimla- Brockhurst- Kasumti, vice-versa.
- II. All buses coming from Upper Shimla to ISBT will commute via: Chhota Shimla-Old Bus Stand- ISBT.
- III. All buses coming from BCS to Old Bus Stand will commute via: Khalini- ISBT- Tutikandi Crossing- Old Bus Stand.
- IV. All Buses departing from Old Shimla towards BCS, New Shimla or Vikasnagar will follow the route: Old Bus Stand –Tutikandi Crossing- ISBT- Lower Khalini- BCS.

The executing agency shall ensure all safety/security precaution to be followed for the pedestrian specially the school children.


