NOTIFICATION

The Hon'ble High Court in CWP No. 6329/2025-titled as Lalit Kumar & Others Versus State of H.P. & another dated 06th October, 2025, and Hon'ble High has passed following order: -

"While placing on record communication dated 03.10.2025, issued under the signatures of Special Secretary (TE) to the Government of Himachal Pradesh, learned Additional Advocate General states that department concerned, after having obtained concurrence of the Finance Department, has prepared and submitted the Cabinet Memorandum to the competent authority for its placement in the Council of Ministers and as soon as decision of Cabinet is given, process for filling-up of posts in question shall be initiated.


Though as per afore communication, six weeks' time has been prayed for, but having taken note of the fact that mandate contained in the judgment, sought to be complied with, was passed on 04.06.2025, there appears to be no justification for this Court to grant further time, but yet by way of indulgence and on the vehement request of learned Additional Advocate General, three weeks' time is granted to respondents to do the needful, failing which, Secretary (Technical Education) shall remain present in Court on the next date of hearing to explain that why appropriate action in accordance with law be not initiated against him for his having wilfully and intentionally disobeyed the mandate contained in the judgment, sought to be complied with. List on 31.10.2025."

In compliance to above orders of the Hon'ble High Court, the order/judgement dated 04.06.2025 in the above referred case is hereby implemented by promoting and posting the following Senior Scale Principals to the post of Deputy Director (Training) in the pay scale at Level 21 in pay matrix (cell-1) as per Rules 3(j) of Himachal Pradesh Civil Services (Revised pay) Rules, 2022, on regular basis with immediate effect in the public interest: -

These Officers are directed to report for duty at their place of posting on promotion as Deputy Director (Training), within 10 days from the date of issuance of these orders positively, failing which it will be presumed that the Officers are not interested and promotion orders shall be deemed as cancelled.


The Officers will remain on probation for a period of two years from the date of promotion and will be eligible to exercise option for fixation of pay under the provision of F.R. 22 within a period of one month from the date of issuance of this order.
