NOTIFICATION

In supersession of this department Notification of even no. dated 08-04-2026, the Governor, Himachal Pradesh is pleased to order to restrict the reimbursement claim under HIMCARE Scheme to the tune of the Actual Expenditure Cost incurred or defined package rates for treatment, whichever is less, in respect of Government hospitals/ Medical/Dental Colleges. Thus, the Government hospitals/ Medical/Dental Colleges shall be able to claim reimbursement the bills for Actual Expenditure Cost incurred plus remuneration of HIMCARE Sathi. The Government hospitals/ Medical/Dental Colleges shall provide cashless treatment to the patients by providing all the required medicines/ items/consumables/surgical items etc. for the same. Further, all the required medicines/ items/ consumables/surgical items etc. related to the treatment of the patients which are available in Government supply/budgeted by the State Government/NHM separately, shall not be claimed by the hospitals/ Medical/Dental Colleges under Actual Expenditure Cost or defined package rates for HIMCARE Scheme.
